Personal data we process

NEW ANGELES INTERIOR STYLING does not process personal data because no personal data can be left on our site. We also do not use social media plugins.

Special and/or sensitive personal data that we process

For what purpose and on what basis we process personal data

NEW ANGELES INTERIOR STYLING processes your personal data for the following purposes:

- To be able to call or email you if necessary to carry out our services.

Automated decision-making.

NEW ANGELES INTERIOR STYLING does not make decisions based on automated processing about things that can (significantly) affect individuals. These are decisions that are made by computer programs or systems, without any human being (for example an employee of NEW ANGELES INTERIOR STYLING) being involved.

How long we keep personal data

NEW ANGELES INTERIOR STYLING will not retain your personal data longer than is strictly necessary to fulfill the purposes for which your data is collected. We use the following retention periods for the following (categories) of personal data:

Contact information > indefinite period of time > contact

Sharing personal data with third parties

NEW ANGELES INTERIOR STYLING only provides third parties and only when necessary for the execution of our agreement with you or to comply with a legal obligation.

Cookies, or similar techniques, that we use

NEW ANGELES INTERIOR STYLING uses only technical and functional cookies. And analytical cookies that do not invade your privacy. A cookie is a small text file that is stored on your computer, tablet or smartphone when you first visit this website. The cookies we use are necessary for the technical operation of the website and your ease of use. They ensure that the website works properly and, for example, remember your preferences. They also allow us to optimize our website. You can opt out of cookies by setting your Internet browser so that it no longer stores cookies. In addition, you can also delete any information previously stored via your browser settings.

Viewing, adjusting or deleting data

You have the right to view, correct or delete your personal data. In addition, you have the right to withdraw your possible consent to data processing or object to the processing of your personal data by NEW ANGELES INTERIOR STYLING and you have the right to data portability. This means that you can submit a request to us to send the personal data that we hold about you in a computer file to you or another organization named by you.

To make sure that the request for inspection is made by you, we ask you to send a copy of your proof of identity with the request. In this copy, black out your passport photo, MRZ (machine readable zone, the strip of numbers at the bottom of the passport), passport number and Citizen Service Number (BSN). This is to protect your privacy. We will respond to your request as soon as possible, but within four weeks.
